DECISION

Town and Country Planning Act 1990 (as amended)

Full Planning Permission Granted

142 Goldhurst Terrace London NW6 3HP

Proposal:

Replacement of eastern side boundary timber fence (between the front gardens of nos. 140 & 142) with new timber fence and provision of new front bin store enclosure. Drawing Nos: (1519-)00, 01, 02, 11 rev A, 12 rev B.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- The development hereby permitted must be begun not later than the end of three years from the date of this permission.
 - Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).
- 2 All new external work shall be carried out in materials that resemble, as closely as



possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24 and DP25 of the London Borough of Camden Local Development Framework Development Policies 2010.

The development hereby permitted shall be carried out in accordance with the following approved plans: (1519-)00, 01, 02, 11 rev A, 12 rev B.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission:

The replacement front bin enclosure will be raised approximately 0.2m to 0.4m and would follow the natural gradient of the sloping front garden. This increase in height will reasonably allow standard wheelie bins to be accommodated in an accessible area within the front garden. Following the submission of revised drawings, the existing upper and lower sections of timber fence will also be raised by between 0.1 to 0.4m to screen the bin enclosure from south-east views along the street and from the adjacent property at no. 140. In terms of materials and design, the replacement timber fence and bin enclosure will match the existing fence and enclosure. Given their modest increase in height and use of appropriate materials, it is considered that the proposals would not detract from the character and appearance of the building and the wider South Hampstead conservation area, and as such, would be acceptable.

There are no amenity concerns as a result of these proposals in terms of loss of privacy or overlooking to neighbouring properties.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received to the proposals following statutory consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposed development is in general accordance with policies CS5, CS14, and CS18 of the London Borough of Camden Local Development Framework Core Strategy 2010; and policies DP24, DP25 and DP26 of the London Borough of Camden Local Development Framework Development Policies 2010, the London Plan 2016 and the National Planning Policy Framework 2012.

2 Noise from demolition and construction works is subject to control under the

Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Compliance and Enforcement team [Regulatory Services], Camden Town Hall, Argyle Street, WC1H 8EQ (Tel. No. 020 7974 4444 or on the website

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Argyle Street WC1H 8EQ, (tel: 020-7974 6941).
