

### **Cedar Tree at 1 Oak Hill Park (TPO-protected)**

This tree has had three medium-sized branches torn from the upper trunk or from larger branches in gales from the W or SW over the past 2/3 years. Over the same period, heavy growth at low level, around 3 to 5m from the ground, has given dense foliage made up of small branches, vulnerable to breaking off eg in a heavy fall of snow.

We wish to carry out the following work, as advised by arboriculturists

- \* Trim stumps where branches have been torn off.
- \* Thin the upper canopy of the tree by 10-15%, including shortening by up to 2m branches most at risk of damage in storms.
- \* Thin the lowest part of the canopy, especially that overhanging the pavement and street, by 20%, reducing overlong branches by up to 2m.
