A FURTHER REPORT SUBMITTED BY MWA ARBORICULTURAL DATED 8.10.2012 IDENTIFIES LONDON PLANE TREE ROOTS ARE MATERIAL CAUSE OF SUBSIDENCE DAMAGE TO 14 WEECH ROAD. APPLICATION MADE FOR REMOVAL OF TREE NOT APPROVED BUT APPROVAL WAS GIVEN TO REDUCE TREE TO PREVIOUS POLLARD POINT IN JUNE 2013. WORKS COMPLETED AUTUMN 2013. A SUBSEQUENT CLAIM FOR NEGLIGENCE WAS MADE BY AVIVA AGAINST OWNER OF PLANE TREE CLAIMING HE SHOULD HAVE BEEN AWARE OF SUBSIDENCE RISK CAUSED BY TREE. THIS WAS NOT EVENTUALLY PROCEEDED WITH AT COURT BUT MR SMITH IS NOW FULLY AWARE THAT FAILURE TO PROPERLY MANAGE TREE COULD RENDER HIM LIABLE TO FUTURE CLAIMS. IT IS INTENDED THAT THIS TREE BE MANAGED TO KEEP CROWN AT LEVEL APPROVED UNDER CONSENT 2013/3478/T
