

GENERAL NOTES

- A. Do not scale from drawings. Check all dimensions and conditions on site.
- B. All works to be carried out in accordance with current health and safety including CDM regulations. All works to comply with current British standards and regulations, codes of practice, Building regulations, and appropriate European standards.
- C. All structural work is to be carried out in accordance with the structural engineers details and calculations.
- D. Precise positions of all fixtures and fittings is subject to confirmation on site.
- E. Allow for the protection of all finishes and fittings that are to be retained.
- F. All drawings are to be read in conjunction with the relevant preliminaries and specification.
- G. All drainage shown is assumed and is to be confirmed on site by specialist.

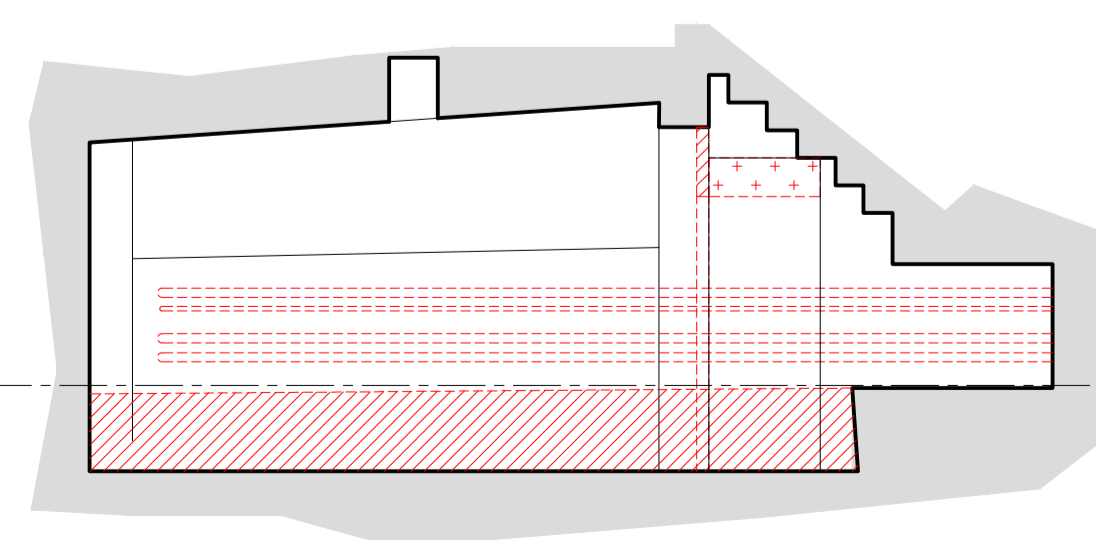
DEMOLITION NOTES:

- Contractor to allow for removal of all existing floor / ceiling / wall finishes as shown/noted on drawings
- All original features such as covings / doors / door frames / architraves / fireplaces / window shutters to be retained unless noted otherwise. Refer to restoration elements schedule for more details.
- Height of new openings shown is finished dimension - allow for depth of lintel in new aperture
- For builders work openings refer to M&E documentation
- Refer to M&E documentation before disconnecting/removal of any services.
- Chases for service risers not shown, ref. proposed architectural plans and M&E information for further information
