T1. Strawberry Tree- Crown reduce by up to 1m all round, lightly thin crown by 10/15%. Remove 1 large limb growth out over the pavement.

Rear Garden of 32 Bartholomew Villas. Contact owner for access:

T2. Bay Tree- Reduce height back towards previous pruning positions. Reduce all side growths to leave a natural/informal shape.

T3. Magnolia- Reduce back towards previous pruning positions, removing around 1m of regrowth and up to 2m where it overhangs the neighbouring property. Lightly thin 10-15%.

(T4. Lilac- No action to be taken)
