'The revised approach is supported in principle as it reduces the impact on the [listed] building...  
Listed building consent will be required for these works, as the approved plans indicate that the creation of an enlarged doorway to the vestibule was only for the purpose of providing temporary maintenance and constructional access to the extended toilet facilities. The approved plans indicate that the existing window and surround would be reinstated to match existing.

The principle of creation of new door with permanent removal of the two windows to safe storage within the building is considered to be acceptable...

...The proposed reinstatement of original hexagonal bulkhead light fittings within the two vestibules with redundant original light fittings from elsewhere within the building and the renewal of non-original floor coverings are considered to be acceptable...'
