Rear Garden:
Large Ash: Located on left hand boundary. Thin crown density by 25-30%. Remove thick proliferation of epicormic growth from central crown area. Remove overlong extraneous branches back into main crown structure. Remove dead wood, dying and broken branches. Reasons - to help curtail the trees sphere of influence, reduce potential hazards and increase light levels whilst preserving natural characteristics and aesthetic value.
Row of Lime: Located on right hand boundary. Reduce crown tops back to previous previous pollard points. Reduce branches overhanging flats to the rear back to as near to boundary as is practicable whilst preserving screen in order to develop pleach. Lateral and sub lateral growth growing between trees should be retained to help form a screen and future pleaching.
Lime: Reduce crown back to previous reduction points whilst preserving a suitable amount of furnishing growth in order to ensure crown continuity.
