Mature Apple: Reduce crown back to previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity. Thin crown density by 30% to include removal of epicormic growth and water shoots. Reason - To maintain tree at a reasonable size for its location and general maintenance.
