T6 = Large HAZEL - crown reduce height and spread by 0.5m. reduce elongated laterals by 0.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.  
T7 = Large SILVER BIRCH - NO ACTION REQUIRED

## 7. Identification Of Tree(s) And Description Of Works

T8 = Large HAZEL - crown reduce height and spread by 0.5m. reduce elongated laterals by 0.5m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.  
T9 = Large PRUNUS (dead) - fell as close as possible to ground level  
T10 = Medium ACER - lightly reduce by 6-8" to form a neater specimen.  
GRP1 = Large mixed WISTERIA CLEMATIS shrubs originating from garden of No.25 - face back overhanging vegetation back as close as possible to fence line (due to access issues this may involve pole snip works).
