## Full Planning Permission Granted

Address: Basement Flat 36 Hemstal Road London NW6 2AL

Proposal:

Erection of a single storey outbuilding in rear garden and alteration to side (west) boundary wall in association with basement flat.

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy CS14 of the London Borough of Camden Local Development Framework Core Strategy and policy DP24 of the London Borough of Camden Local Development Framework Development Policies.

3 The development hereby permitted shall be carried out in accordance with the following approved plans Hemstal/16/A/01; Hemstal/16/A/02; Hemstal/16/A/03; Hemstal/16/A/04; Hemstal/16/A/05; Hemstal/16/A/06; Hemstal/16/A/07; Hemstal/16/A/08; Hemstal/16/A/09; Hemstal/16/A/10; Hemstal/16/A/11.

Reason: For the avoidance of doubt and in the interest of proper planning.

4 The outbuilding hereby approved shall only be used for purposes incidental to the residential use of Basement Flat, 36 Hemstal Road and shall not be used as a separate or independent use, including residential living accommodation.

Reason: To ensure that the outbuilding does not adversely affect the amenity of adjoining residential premises, in accordance with policy CS5 of the London Borough of Camden Local Development Framework Core Strategy and policy DP26 of the London Borough of Camden Local Development Framework Development Policies.
