Moving the D1 unit to the basement will be detrimental to that type of business as the current ground floor location works very well in relation to customers arriving, waiting and being treated. The 3 treatment rooms with skylights work really well for customers as it is very calming to be able to look at the sky when dental work is underway. The plans for the basement area include a skylight which is welcome but that is at the far end of the building and is angled so that overall it will not be easy to incorporate that into treatment rooms where a range of equipment needs to be fitted. It does not look like it will be easy to get the treatment chairs to align with the skylight. Another point is that the current D1 use presents a very active frontage to the street, the movement of customers in and out, the reception staff activity and the full glazed facade all contribute positively and strongly to the vitality of the street. I also have doubts about a shared reception for the whole building. What do the architects mean when they say it will be permanently staffed? Is that 9-5 Monday to Friday? What happens when the operations in the building run outside those hours? For the D1 activity it means they are not in control of their entry door which is a vital part of their operation, in addition to which there may be patients who do not wish to arrive at one reception for the whole building but wish to access the dentist direct (confidence issues or confidentiality issues are rrelevant here). So my belief is that this application if given permission would be detrimental to the running of the D1 business for the reasons outlined above.
