SCHEDULE OF WORKS

We write on behalf of our client, Ms Kay Georgiou, in follow up support of application reference 2016/5703/L, submitted to the Council and validated on 25 October 2016. The application refers to the re-discharge of part of condition 7 (replacement of windows), attached to planning permission 2015/4560/L.

Following submission and validation of application 2016/5703/L, a detailed survey assessing the condition of all window boxes was undertaken by Iceni Heritage to provide evidence in support of the justification for the removal and replacement of window boxes. The detailed results of this are in the possession of the Council. As such, this schedule of works provides a summary of some of the findings.

Schedule of works

The below is a summary of some of the findings following an onsite window survey carried out on 20 December 2016. Full details, plans, and photographs demonstrating the results of the condition survey are held in the Council's records.
