
We cannot cope with another huge development. My child was not offered a local school place. The schools do not have public transport network cannot cope!!!

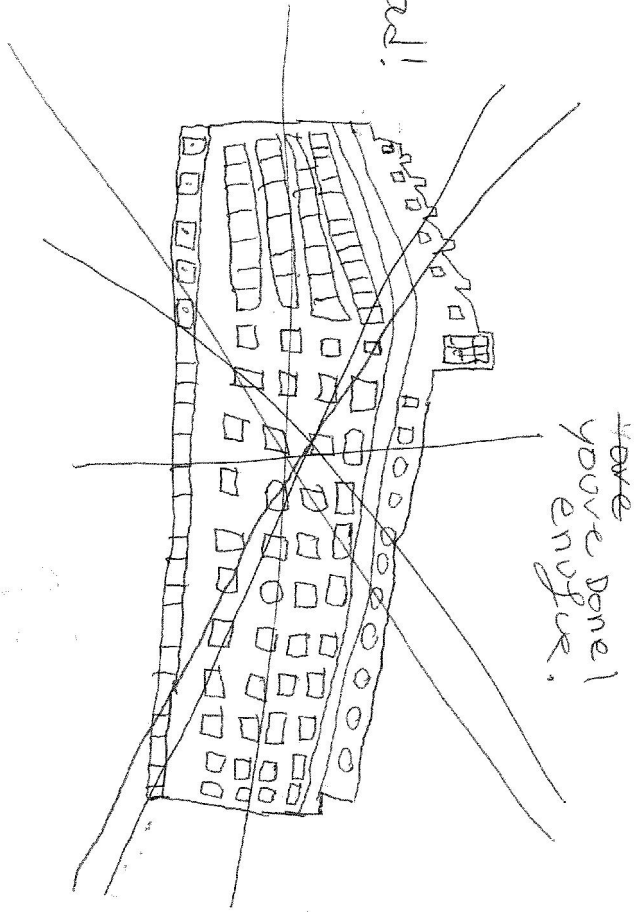
