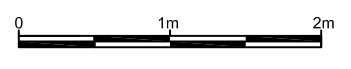

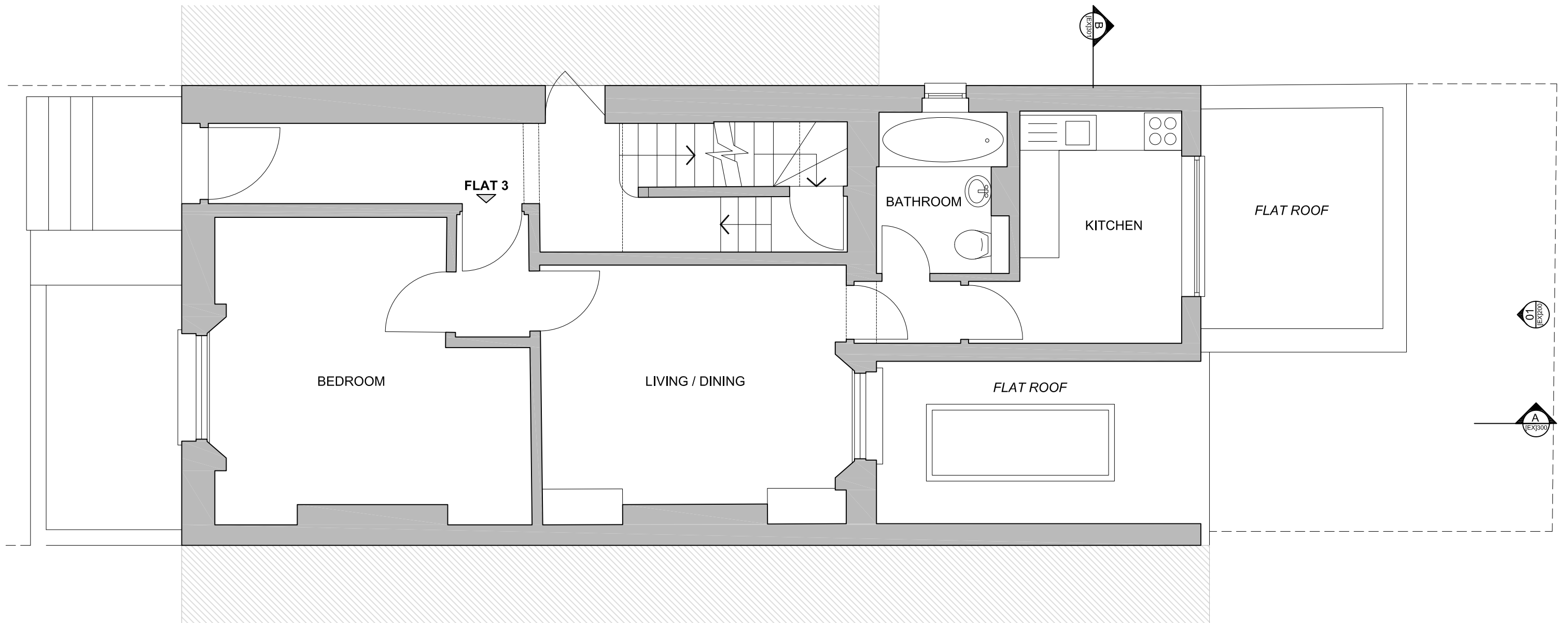


01 EXISTING: LOWER GROUND FLOOR PLAN

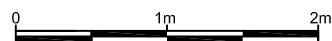


01 EXISTING: GROUND FLOOR PLAN

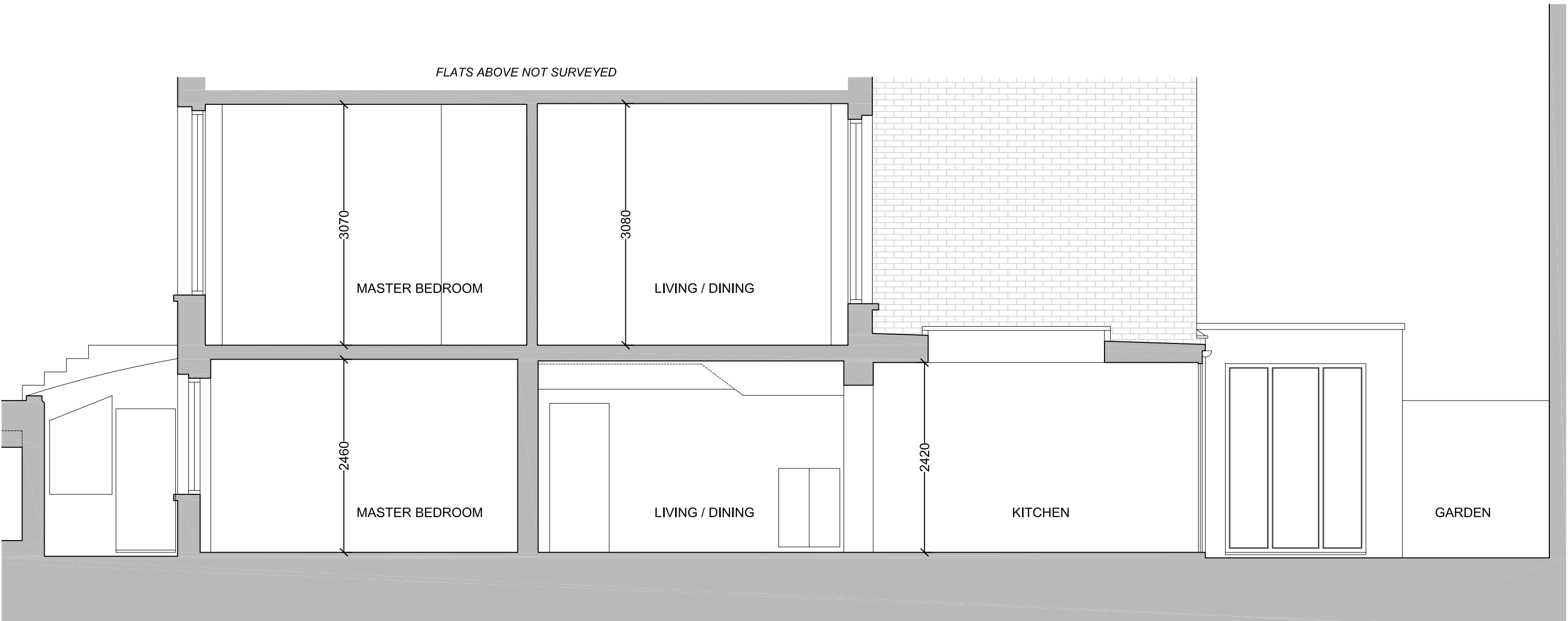


01 EXISTING: REAR ELEVATION

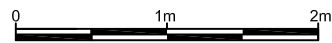

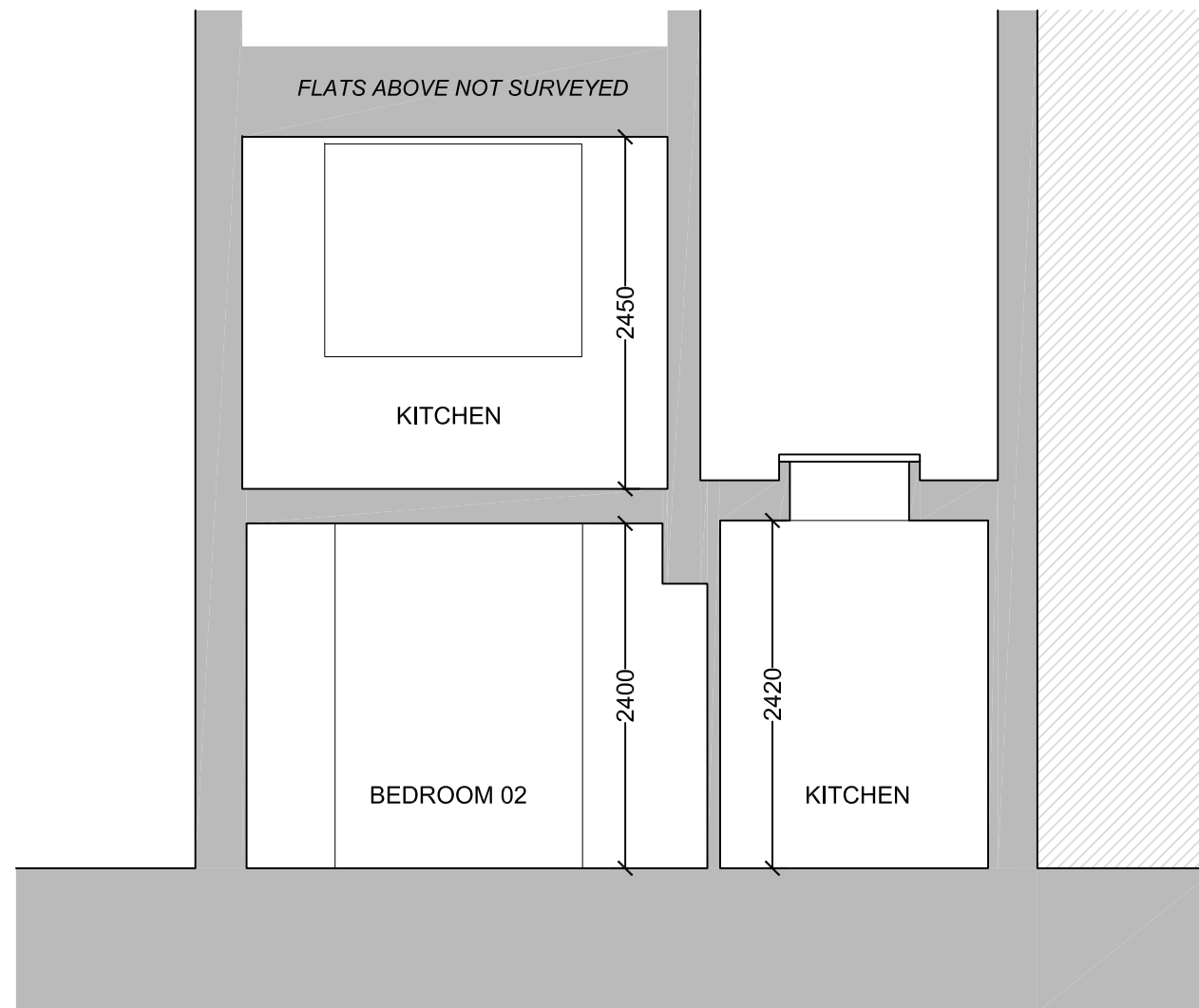

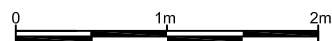
