Work required- Crown reduce by removing 0.5-1m from height, and by removing 1.5m from sides, to form a balanced shape, also to reduce the risk of further branch failure by reducing the lever arm effect as the lower side branches are extruding out from the crown and the has been been branch failure previously because of this.

Raise the lower canopy over the footpath to approximately 3m.

Remove all the ivy within the canopy but leave it on the main stem.
