London plane growing in the hospital grounds next to Fleet Road. Fell. It is damaging a retaining wall which has become a serious hazard to the public footway and carriageway on Fleet Road. Joint investigation by the engineer and arboriculturist indicates that the wall could not be rebuilt to an adequate standard with the tree in situ.

There is space to plant a replacement farther back from the wall, species to be agreed with LB Camden, could be another plane or similar alternative.

More information on these matters is in the attached engineering and arboricultural reports.
