E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

It is proposed to remove the boundary wall located within the Root Protection Area of the Holm Oak located in the front garden of 104 Haverstock Hill and replace it slightly to the south. The reason for this is the existing wall is unstable due to the root growth of the subject Holm Oak. This has been confirmed by Hurst Peirce + Malcolm (Consulting Civil and Structural Engineers) on 18th March 2014. The boundary wall is currently supported by temporary wooden struts.

Also reduce crown of Holm Oak by 1m all over to achieve a height of 10m and a crown spread of 3m north, 3m east, 4m south and 3m west.
