26 Christchurch Hill London NW3 1LG: Basement extension

We are writing in regard to the revised planning information for a listed building consent and planning application for the above property. The revised architectural drawings (plans & sections), are itemised overleaf and contain the following amendments:

- Omission of the tunnelled excavation below the root protection areas (RPA) of the lime tree (T2);
- A single, smaller rooflight replacing the three rooflights, positioned next to the terrace wall away from the rear facade;
- A sunken courtyard showing detailed treatments of the glazed canopy, together
 with images of the timber glazed canopies of precedent case studies, see 20.301.
 Also, part existing and proposed elevations of the sunken courtyard when viewed
 from the rear garden (included in drawing, 20.201).
- Details of the depth of substrate at the proposed location for the new apple tree, (see 20.301); and the proposed drainage requirement is shown in 00.011.

We have also included a response to the Public Consultation Comments.

Finally, as agreed, the additional details required to address Campbell Reith's comments outlined in their report will be provided by 1 st February.
