Front Garden:
T1 - T4: 4 x Magnolia Grandiflora: These trees growing against building are now encroaching over windows and some maintenance of these trees is now warranted. Reduce back to clear building by at least 100mm. Reduce back from window and guttering. Reduce reaming crowns by 20%, (formative prune).
T5 - Large Olive: This tree does not appear overly vigorous. Remove dead wood and reduce crown by 30%.
Rear Garden:
T6 - Mimosa: This young fast growing tree is leaning on the building and will need increased support from the building as it grows. The heavy lean and structure of this tree along with the species vulnerability to root plate movement lend us to suggest the tree's removal at this juncture. Fell to ground level.
T7 - Leaning Goat Willow: This tree has a heavy lean, poor form and is in a poor condition. Fell to ground level.
T8 - Dead Macrocarpa: Fell to ground level.
