G2 - Ash Saplings: Approximately 4.00m. Remove two in 7a and reduce height of remaining by 30%.

G3 - Holly Hedge: Reduce extraneous growth back into main crown structure.

G4 - Row of Leyland: Approximately 5.00m. Reduce height by 1.00m. Trim overhang as is practicable to control encroachment.

Right Hand Boundary:

T2 - Sorbus: Approx. 7.00m. Reduce crown by 20%. Thin crown density by 20%.

T3 - Elder: Leaning. Approx. 5.00m. Fell to ground level.

T4 - Leyland Cypress: Approx. 5.00m. Reduce crown by 30%.
