T1 London Plane x 2 (Platanus x hispanica) Extra large, mature, widespreading trees. These two trees have been reduced in the past. This was done to reduce the moisture uptake and increase light. To further reduce the moisture uptake, the suggested works are: To reduce both trees to approx. 1 - 1.5m below the previous reduction points, clean out crowns, remove deadwood.
