Please state why you wish the condition(s) to be removed or changed:
We are requesting two minor amendments to the existing approved drawings.
The first one is to add a second rooflight to the side infill extension. The proposal has an approved rooflight above the shower room. We are requesting an additional skylight above the hall area.
The second amendment is to increase the overall height of the side infill extension by 150mm. This would allow, following coordination with the SE, for the correct depth the pitched roof and would allow to keep the existing approved interior headroom and size of external door.
