Following the mail of 2nd February, we were invited to participate in a formal pre-application process (at a quoted cost of £960). We responded as follows:

Thank you for your mail in relation to the above.

While I appreciate that Camden Council have a formal and chargeable process for pre-application enquiries, our clients clearly have to weigh up the time and cost involved, compared to what is essentially a minor scheme to merely add (net) one small equipment cabinet to an existing telecommunications site. In such case, it is considered commercially impractical to pursue a formal pre-application enquiry, particularly given the time and cost that will be incurred with the formal application process (and one that in terms of cost will be almost a third of your pre-app charge).

If there are any issue that arise during the currency of the application, we can deal with them at that time, but we do not expect there to be any major concerns for a proposal of this nature.
