2016/5355/P	Jacinta Watts	15 Doughty Mews	09/02/2017 12:30:41	OBJ	<p>I would like to submit an objection to the proposed installation of 1 x AC unit at roof level on the application for 16 Doughty Mews.</p> <p>Should the air conditioning unit be fitted at roof level, it will be at the same level as our roof top space which currently only has single glazed windows. This will mean that the noise that the AC unit will produce will be clearly heard at our roof top level. This will cause much disturbance for myself, my husband and the young family we are hoping to start soon.</p> <p>We currently use our roof top as an area to enjoy our outside space. Not only will the noise cause disruption but the unit will be deleterious to the amenity of this conservation mews.</p> <p>I have lived in Doughty Mews since late 2010 and have always enjoyed the character that not only the Mews has but Bloomsbury has as a whole. I feel that the addition of this unit will be in direct conflict with preserving this historic nature of this area.</p> <p>Further to this, I have concerns of the environmental impact that the unit will have in the area. It has been widely proven that air conditioning units produce and discharge soot and other many harmful pollutants. I feel that there are more suitable options for the owners to consider. These options include eco-friendly inside installed units or the installation of a green house. As the United Kingdom as a whole is not known for its heat, I do not see the practicality of installing an air conditioning unit. Given that the options that I have suggested would be less of an impact on the environment and the immediate surrounding area, I think these would be better suited than installing the proposed unit.</p> <p>I am happy to discuss this further with the planning committee if required.</p>

We have asked the applicants to consider these alternatives but our requests have been dismissed as indeed were the issues we raised over the elastic nature of their building operations.</li> </ol>
