E.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with 1 standard ash in the same place.

T.1 Beech - Reduce crown by 2-3 metres in lateral spread and height. Cuts to be made back to a suitable growing point that maintains a flowing branch line and character of the tree. Cuts not to exceed 100mm diameter to a side shoot not less than 1/3rd diameter of parent stem. Crown lift to 5 metres all round by the removal of minor pendulous branches.

T.2 Holm Oak - reduce entire crown by not more than 2 metres in in height and lateral spread and height. Cuts to be made back to a suitable growing point that maintains a flowing branch line and character of the tree. Cuts not to exceed 100mm diameter to a side shoot not less than 1/3rd diameter of parent stem. Crown lift to 5 metres all round by the removal of minor pendulous branches.

Reason- To reduce wind load on trees which have recently been exposed following the demolition of the adjacent building and encourage the formation of a smaller denser crown for the future. Loading likely to change rapidly due to construction of new building which could increase risk of branch failure.
