Rear Garden:  
Mature Birch: Approximately 13.00m. This tree appears in fair condition. Ivy is advancing from main stem into the crown. Remove ivy from crown and retain ivy on main stem. Reduce crown by approximately 20%. Thin crown density by 20% and remove dead wood throughout crown.  
Lime: Approximately 10.00m. Condition fair. This tree appears vigorous and forms essential screen from the properties to the rear. Reduce crown by 25%, thin crown density by 20% and remove dead wood throughout crown.  
Bay: Approximately 7.00m. Condition good. Located in 37 Shirlock Road and overhanging the boundary. Reduce crown by approximately 30%.  
Reasons: The above actions will help manage the trees at reasonable dimensions for their locations, increase light levels, reduce potential hazards and promote a more balanced crown structure whilst preserving tree health, natural characteristics and aesthetic value.
