RE: 2017/0437/P; o/s 20 Camden High Street, London NW1 0JH Erection of freestanding Link unit with associated services following the removal of BT telephone kiosk.

With respect to the above application, TfL have the following comments:

- ∞ The site is located on the A400 Camden High Street, which forms part of the Transport for London Road Network (TLRN). TfL are the highway authority for the TLRN.
- In the submission material, the applicant has referenced TfL's Digital Roadside Advertising Guidance. However, as shown on the Advertising Safety Guidance Framework at Appendix A of this guidance, TfL do not normally permit digital advertisements within the controlled zone of pedestrian crossings due to the potential impact on public safety of drivers being distracted from the signals. This proposal is located within the controlled zone of the crossing, as shown by the zig-zag markings on the carriageway.
- Given this, TfL would recommend that the application is refused. However, if the application is permitted or the subject of any appeal we would request that the applicant's suggested conditions are secured on any consent.
