Rear Garden:

Apple: Approximately 7.00m. Reduce crown by approximately 30%. Thin crown density by 20%. Remove dead wood and broken branches. To increase light levels whilst preserving natural characteristics and aesthetic value. It would be prudent not to allow this tree to exceed its current crown height and spread.

Pear: Approximately 4.00m. Fell to ground level due to over crowding.

Viburnum: Fell to ground level as in poor condition.

Front garden:

Cherry: Approximately 6.00m. This tree appears to have been badly pruned in the past. Several poor pruning wounds are evident and the tree is somewhat misshapen. Remove dead wood. Remove stubs left from previous pruning. Reduce and re-shape crown, 15-20% reduction as is necessary to help balance crown and to promote a healthy and balanced crown structure.
