LS9904207 Chapel of Ease, St George's Gardens WC1

The Committee welcomed the repair of the building.

PS9804805R1 21-25 Mecklenburgh Square WC1

The Committee wished to make a site visit before making a final comment. Concern was expressed about the reasr extension and internal alterations.

PS9805054 11-15 Argyle Square

The Committee regarded the standard of accommodation proposed and the scale of the proposed extensions to be contrary to the special interest of these listed buildings. It regarded the proposed use to be over intense. Overall, the proposals would tend to degrade the buildings and would have a seriously detrimental effect on the character and appearance of the conservation area.

PS9904196 32 Percy Street

The Committee wished to object to the extent and design of the proposed rear extension which it regarded as excessive and detrimental to the apparently intact rear façade of the building. In addition, the Committee did not regard the 'restoration' of the front ground floor façade to be desirable in the context of the street which featured a number of shopfronts. However, if such a treatment was to be contemplated it would need to be based on firm historic evidence of the earlier condition.

PS9904134 The London Foot Hospital Fitzroy Square W1

The Committee wished to object to the proposed extensive plant installation in the strongest terms. It was simply not acceptable for a Grade I building of this importance in such a prime location. The Committee questioned the suitability of the present use of the building if it resulted in such damaging installations.

PS9804997R1 50c Red Lion Street

The Committee was concerned about the quality of the drawings and the quality of the NOBJexecution of the works.

AS9904181 184 Shaftesbury Avenue WC2

The committee considered that the projection of 1.2m was excessive given the width of the pavement, the scale of the building and other signs in the street. It felt that the sign would be unduly obtrusive to the detriment of the visual amenities of the area.

LS9904260 23-26 Gt James Street WC1

The Committee welcomed the change of use.

PS9904257 52-53 Bedford Square WC1

The Committee did not wish to comment on this proposal.

PS9904261 52 Red Lion Street WC1

The Committee did not wish to comment on this proposal.

PS9904243 11-13 Macklin Street WC2

The Committee did not wish to comment on this application.
