Dear Kate Henry

I am writing in regard to 2017/0415/L and 2017/0414/P, relating to the Cleveland Street Warehouse and would urge that both applications should be refused.

The historic Workhouse should NOT be gutted for costly apartments for the rich and the remainder of the land should NOT be cleared for building as if it were any ordinary brownfield site - this site is part of London's rich historic heritage and embodies London's health care history since the 1770s.

The assemblage of buildings and the graveyard are like a time-capsule, sealed in 2006 when the hospital closed. There are also likely to be significant elements of industrial heritage, for example relating to the pin-making manufactory employing children there in the early 19th century.

The whole site, including the Workhouse and the subsidiary buildings on the site, deserves a full forensic archaeological investigation before any new plans are made for it.

Dear Kate Henry,

I am currently a Senior Research Fellow at the Institute of English Studies, School of Advanced Study, University of London, and have been a resident of the Borough of Camden many times. (I even have a granddaughter named Camden—her parents' choice, not mine.) I was the first Scholar in Residence at the Charles Dickens Museum during the Dickens bicentenary year, 2011-2012, and have published or will be publishing five books on Dickens with Oxford and Cambridge University Presses.

The idea of destroying the historical buildings associated so intimately with the formative years of Britain's greatest novelist must be a non-starter. Greed should never prevail over outstanding historical edifices. Moreover, to dig up a graveyard strikes me as the ultimate in disrespect for religion in general and those deceased in particular. It violates the very promise made when those grounds were consecrated in the eighteenth century.

These proposals are not in keeping with Britain's vital tradition of preserving memorials. It goes against everything the nation has accomplished in the way of curating its heritage for Camden Council to countenance such ruthless, uncaring, and in the case of the burial ground sacrilegious devastation.

Please stand up for England's enormously rich and moving history that brings so many to its shores.
