Tree Location Work proposed

T1-Magnolia (Magnolia spp)

This tree has been reduced in the past in order to maintain this suggested works are: Reduce back to previous reduction points, approximately 1m-1.5m from branch tips, retain furnishing growth ,clean out crown and deadwood.

T2-Pear(Pyrus spp)

Recently reduced tree suggested works are : Clean out crown and cut back over lawn

T3-Silver birch (Betula pendula) Front left

Rear boundary (neighbours tree)

This is a mature, specimen tree which is unusually large for it species. It is encroaching over the boundary and is blocking light and also causing problems to the gutters and drainage due to the large amount of leaf and seed litter. Due to the size, it is likely to be a fairly old specimen. The tree seem in good health, however there are a number of limbs which are end heavy and could potentially be at risk of failure. Suggested works are: Reduce back overhang to suitable new growth points by approximately 30-35% to boundary. Carry out climbing inspection, Clean out crown and remove deadwood.

All works will be carried out in accordance with British Standard 3998
