- A section of the garden/boundary wall has been painted as indicated on dwg 3884/PL01. Consent is sought for the retention of this paint finish on the listed wall.
- 14No. wall mounted lights used for pedestrian security in Green Yard are to be retrofitted with hoods / replaced with hooded versions to direct the light downwards towards the pavement. See dwgs 3884/PL01 and 3884/PL02 for detail.
- The main gate closure system currently causes a nuisance with slamming noise. The proposal is to fit a new controlled closing system to the existing gate which will prevent slamming. Details shown on dwg 3884/PL02
- The unauthorised camera and the associated cabling and ducting (CCTV2; see 3884/PL01) to be relocated from the listed front elevation of 49A Gough Street to front elevation of 50 Gough street (see photograph G on dwg 3884/PL01) – which is not a listed elevation.
