REMARKS: Dear Elaine,

Thank you for your time and guidance over the last weeks. As advised, a section 73 application has now been made in relation to external plant and modifications to rear lightwells across the properties 8-11 Montague Street and 39 Russell Square. Following further confirmation via telephone (ref: 00576 on the afternoon of Wednesday 15th February), this has been submitted as a 'Removal/Variation of a condition' type application on the Planning Portal and the descriptions within the forms reinforce the above intention for a section 73 Minor Material Amendment.

This new application primarily relates to the reinstatement of an external rear lightwell and clarification of external plant. The acoustic report that relates to the external plant in this application is now in progress and will be submitted to you within a week.

As agreed, we have also taken this opportunity to provide the requested updated drawings that clearly note 'AS CONSENTED' and 'AS PROPOSED' in relation to the current listed building application ref PP-05603043. This information can be downloaded by following the above link. In addition, you will find electronic versions of the summary schedules tabled and handed over at our meeting on the 20th December 2016, together with a summary note and door schedule information in support of the minor fire upgrade works to internal doors.

For ease, the information is packaged in folders in the order described and recorded at our meeting. To avoid confusion it would be simpler to supersede the current listed building application information with this, despite the overall content being the same.
