
Our Third Party Developments Manager comments:

"The development site is very near to Crossrail's Westbound tunnel which is shallow (just 12 meters below ground level) at this location and so there is a potential risk of impact to our assets which need to be properly mitigated. There is also a risk of unacceptable transmission of groundborne noise & vibration emitted from the railway into the new development which also needs to be checked.

Please may we know if the development is the subject of a Planning application. Please may we have details of the development scope and programme.

I would be happy to discuss requirements for the developer's demonstration of due protection of Crossrail assets, if this is helpful and if they contact me to arrange a meeting. I look forward to receipt of more information."
