Details required by Conditions 7 (cycle storage area) and 11 (refuse storage area) granted under appeal reference APP/X5210/A/14/2216978 (2013/7259/P) dated16/09/2014 (Demolition of existing 4 storey building comprising 8 flats and erection of 6 storey building comprising 12 flats (Use Class C3)). The Council has considered your application and decided to grant permission subject to the following condition(s):

1 Reasons for granting permission.

The proposed external area for 12 cycles, by virtue of their size and accessibility, provides secure and covered storage which would meet the Council's cycle



storage standards. The details of refuse are also considered appropriate in terms of size, access and location and therefore the submitted details are acceptable. The full impact of the proposed development has already been assessed. The proposed details would not have a harmful impact on the appearance of the host building and streetscene or on neighbouring amenity.

The planning and appeal history of the site has been taken into account when coming to this decision. No objections were received prior to making this decision. As such, the proposed development is in general accordance with policies CS5, CS11, CS14, CS15 and CS18 of the London Borough of Camden Local Development Framework Core Strategy, and policies DP17, DP24, DP25 and DP26 of the London Borough of Camden Local Development Policies and policies D1, D2, A1, CC5 and T1 of Camden Local Plan Submission Draft 2016.
