T1 False Acacia x 1 (Robinia pseudoacacia) Large, mature, widespreading tree. The tree is in close proximity to the neighbouring property and it overhangs the roof. The limb above the roof has already lost a sub dominant branch over the roof through a failure at the main union. To reduce the moisture uptake and to reduce the mechanical loading on the tree, the suggested works are: To reduce the overall height by 2.5 - 2.75m, reduce the lateral spread all round by 2 - 2.5m, clean out crown, remove deadwood. T2 Portugeuse Laurel x (Prunus lusitanica) Mature tree. The tree is in close proximity to the neighbouring property. To reduce the moisture uptake, the suggested works are: To reduce the height and the lateral spread all round by 1 - 1.5m, clean out crown, remove deadwood. T3 Silver Birch x 1 (Betula pendula / alba) Mature tree. The tree is in close proximity to the neighbouring property. To reduce the moisture uptake of the tree, the suggested works are: To reduce the height by 2m, reduce the lateral spread all round by 1 - 1.5m, clean out crown, remove deadwood. T4 apple x 3 To maintain these trees, the suggested works are: To prune all round by 0.5m.
