Cotoneaster Hybridus Pendulus - fell because tree trunk is pressing against both the front wall to our property and to that of our neighbour at the side. It is beginning to cause damage to both these walls. We have tried to restrict the growth of this tree over several years through aggressive pollarding but this has not proved successful. The tree causes excessive shading both to our front windows but also to our neighbour - to her kitchen and other windows.

The tree will be replaced by a holly tree which we have planted immediately adjacent. The holly tree has increased in size in recent years and will continue to prosper provided it is allowed more room to grow.
