Rear Garden:

Cherry: Located left hand boundary, adjacent boundary wall. Approximately 8.00m. This tree does have merit for its aesthetic value. It is within close proximity to the wall. A possible area of decay on main stem was noted. Some maintenance is warranted. Reduce crown by approximately 30%, thin crown density by 20% and remove dead wood.

Fig: Approximately 4.00m. Fell as inappropriate species for its location.

Multi-stemmed Horse Chestnut: Multi stemmed. Approximately 20.00m. Located rear of 3a Harley Road. This heavily ivy clad tree is causing heavy shade. It is apparent that the tree has been pruned within the last 10 years. The ivy however has not been treated for considerably more than 10 years. Reduce crown by approximately 20% to most recent reduction points whilst retaining a suitable amount of furnishing growth in order to ensure crown continuity and preserve aesthetic value. Remove several suppressed stems emanating from base of tree which are overhanging 155 King Henrys Road and remove ivy.

Cotoneaster: Overhanging from 5 Harley Road. Reduce overhang by 30% to abate nuisance.
