HEAD WEST ON M25. AT JUNCTION 23, TAKE THE A1(M)/A1081/A1 EXIT TO HATFIELD/BARNET/LONDON (NW). AT THE ROUNDABOUT, TAKE THE 2ND EXIT ONTO THE A1 SLIP ROAD TO LONDON (N&C)/BRENT CROSS. CONTINUE ONTO A1. AT STIRLING CORNER, TAKE THE 2ND EXIT ONTO BARNET WAY/BARNET BY-PASS/A1. SLIGHT LEFT TOWARDS WATFORD WAY/A1. SLIGHT LEFT ONTO WATFORD WAY/A1.
