On behalf of our client, Almacantar (Centre Point) Limited, we enclose for your attention and consideration an application to formally discharge condition 6c, attached to the listed building consent in respect of the proposed RO1 unit at Centre Point (2015/5069/L).

## Condition 6c states:

Detailed drawings, samples of materials and method statements as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

c) Samples and manufacturer's details of materials for the internal handrail and balustrade.

In accordance with the requirements of Condition 6c we enclose plan and section drawings prepared by Lee Warren and a sample sheet demonstrating the details of the proposed materials for the internal handrail and balustrade.

The wall to the eastern side of the staircase permitted under application reference: 2015/5069/L is not proposed to be installed. Therefore a temporary balustrade is proposed to extend also on the eastern side where the wall is omitted. The proposed temporary balustrade will be fixed to the floor which is not listed fabric. Details of this balustrade have been submitted with this application.

A sample of the material proposed for the handrail and balustrade is available for officers to view at the factory site if required.
