- Thin crown to remove approximately 15% of live branches to improve light and air penetration through crown. Most thinning cuts will be between 1 and 2 centimetres in diameter

Prune T2 Ginkgo located at the back of property according to the following specifications:

- Trifurcated tree remove middle stem and right hand side branch.
