The rationale behind the proposed non-material amendment is to achieve an improved layout of internal accommodation together with subtle enhancements to the architectural treatment of the external fenestration, which would provide a much more balanced architectural composition of the requisite elevation, given that the approved roller shutter in light of the more recent planning permission, no longer serves a useful planning purpose.
