**ENFORCEMENT NOTICE**

**ISSUED BY: THE LONDON BOROUGH OF CAMDEN**

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.
2. **THE LAND TO WHICH THE NOTICE RELATES**  
  
**Land at: 12 Gower Mews , London, WC1E 6HP** as shown outlined in black on the attached plan ("the Property").
3. **THE BREACH OF PLANNING CONTROL ALLEGED**  
  
**Without planning permission:** Installation of bi-folding doors on the front elevation of the property at ground floor level.
4. **REASONS FOR ISSUING THIS NOTICE:**
  - a) The unauthorised development has occurred within the last 4 years.
  - b) The loss of the existing coach doors and Collinge hinges and their replacement with full height bi-folding doors, by virtue of the detailed design and location has a detrimental impact on the character and appearance of the host building and the row of mews properties and results in harm to the setting of the adjacent listed buildings and the character and appearance of the wider Bloomsbury Conservation area, contrary to policy CS14 Promoting high quality places and conserving our heritage) of the London Borough of Camden Local Development Core Strategy; Policy

DP24 (Securing high quality design) and DP25 (Conserving Camden's heritage) of the London Borough of Camden Local Development Framework Development Policies; and policies G1 (Delivery and Location of Growth) and D1 (Design) and D2 (Heritage) of the Camden Local Plan Submission Draft 2016.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

**5. WHAT YOU ARE REQUIRED TO DO**


Within a period of **three (3) months** of the Notice taking effect remove the unauthorised garage doors located on the front elevation; and

- i) reinstate doors to replicate the original; or
- ii) reinstate doors to match the approved doors (ref: 2015/6593/P dated 07/03/2016) as shown on drawing (Prefix: 317\_00\_) 00A, 01, 02, 03; (Prefix: 317\_01\_) 01A, 02, 04, 05

**6. WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **5 May 2017** unless an appeal is made against it beforehand.

**Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002**

### YOUR RIGHT OF APPEAL

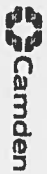
