PPC Alu Khaki Green fascia boxes to be installed/retained where possible, with individual internally illuminated LED signage

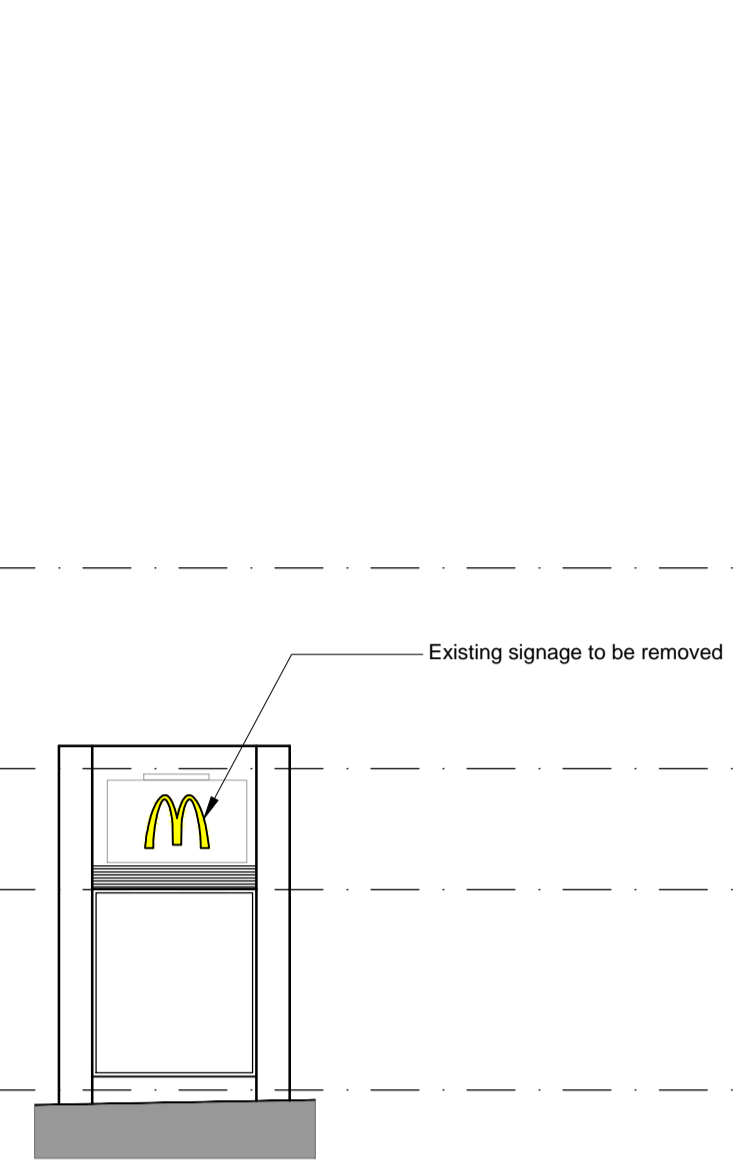

All works to be undertaken within current Building Regulation A Doc's, British Standards and appropriate codes of practice.

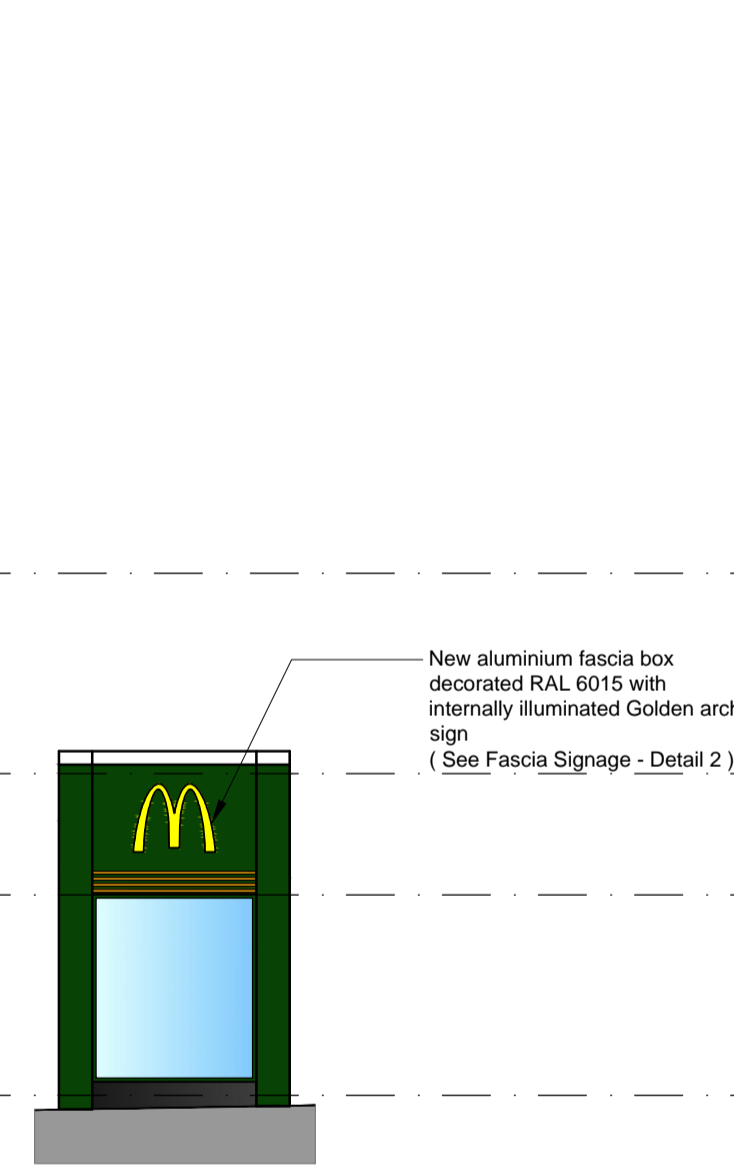
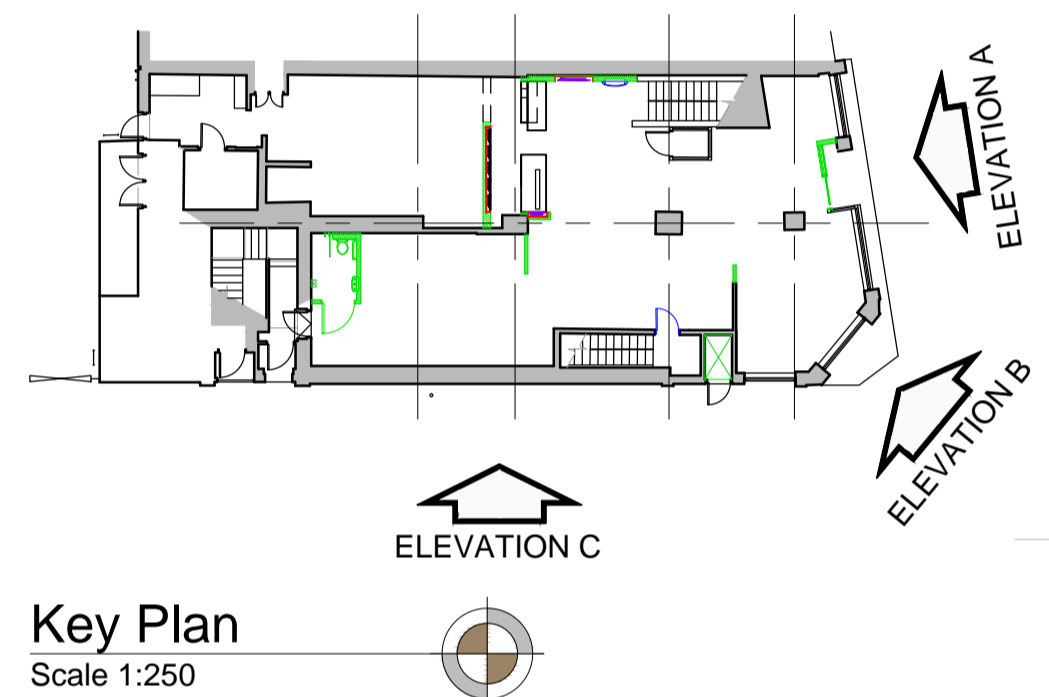

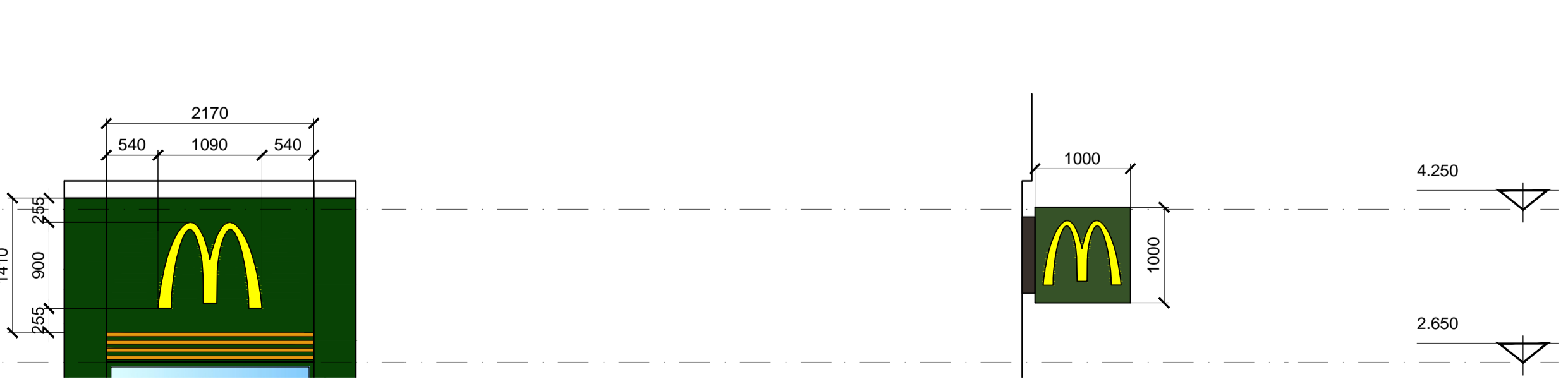
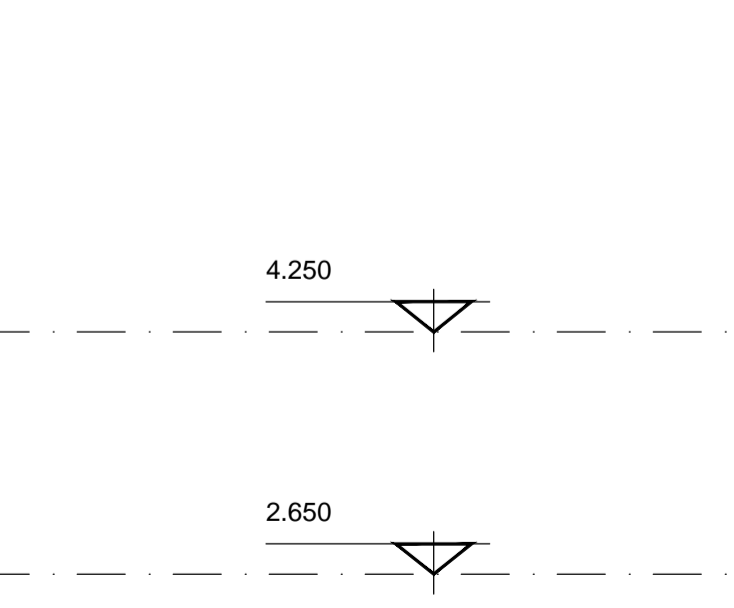
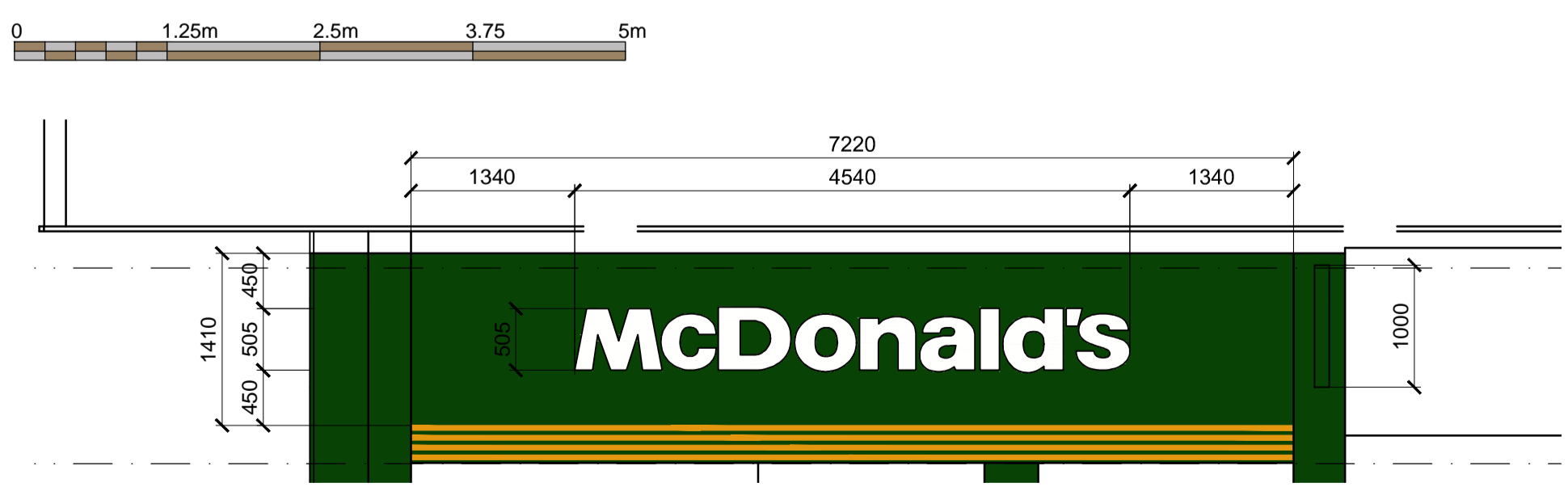
Existing Elevation C
