Overall it is considered that the front and rear dormer extension as previously proposed would be unacceptable in design and appearance, representing incongruous additions. This is highlighted further in the contextual elevation drawing showing majority of the properties within the terrace which benefits from dormer extensions are proportionate in their size and scale. The alterations to the windows and doors to the rear elevation for a modern style design would appear incongruent to the building, fails to enhance the aesthetics of the host building and would have a detrimental impact on the character and appearance of the Hampstead Conservation Area.

Note that the design proposals have been revised to take on board the above advice, keeping the proposed dormer roof extension in proportion and scale with those existing, and revising the rear fenestration as requested.
