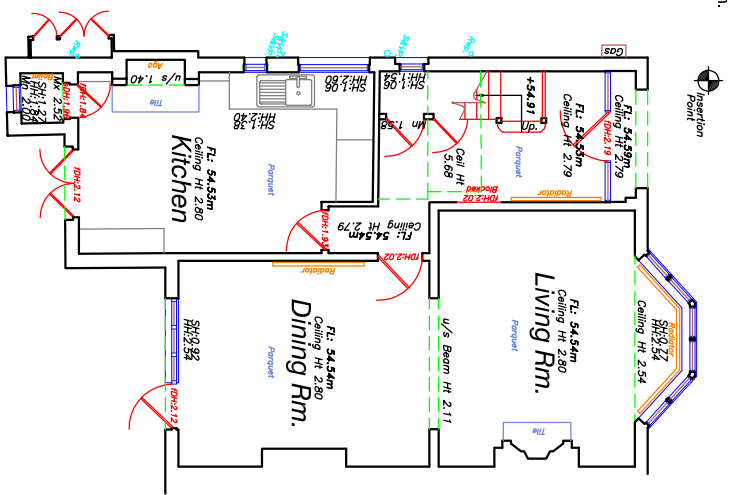
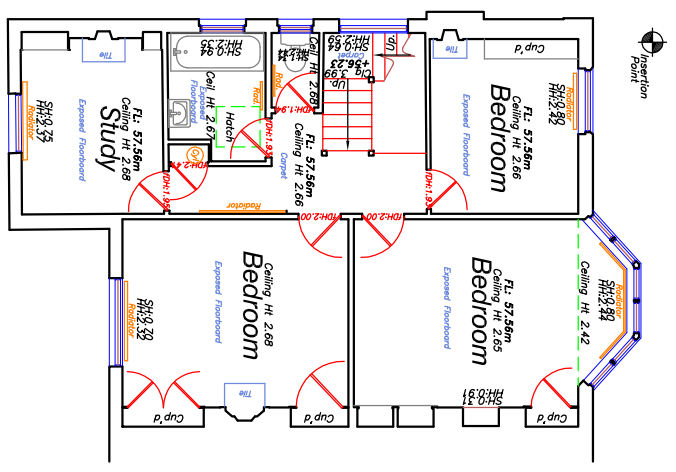


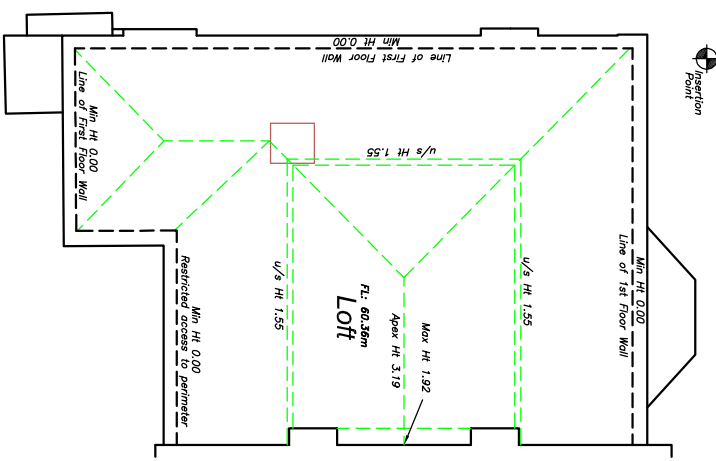
Ground Floor Plan.



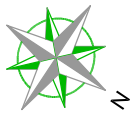
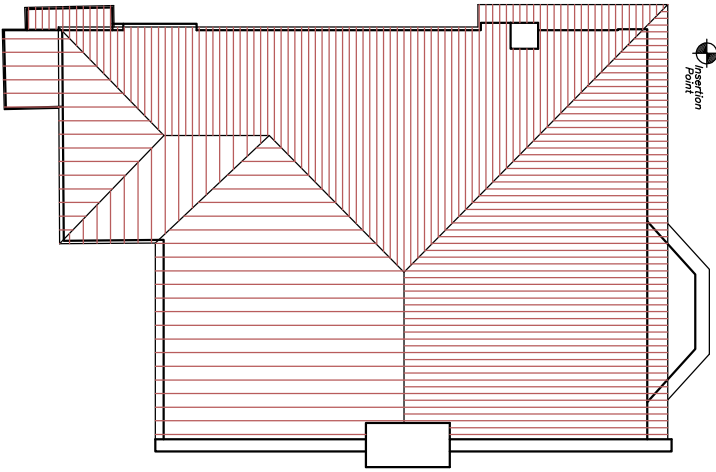
First Floor Plan.
