					1. Loss of privacy. There are currently no existing windows with any direct view of the back of my property. The side wall of 17 Huson Close
					is only 15 metres from our rear windows and thus also a concern under Camden's own guidelines. As you will be aware the windows on
					the Chalcot estate houses are very large and could allow anyone so minded a floor to ceiling view into our bedroom, reception room and kitchen.
					The patio at the back of my property is very private and not overlooked at all by any one, and my patio windows, at 3.4m by 2.1m, reveal
					the whole kitchen and dining space. The privacy we have enjoyed will cease if the side window in 17 Huson Close is permitted. While the
					glass to be installed is labelled as obscuring there is no permanent guarantee as to the how complete this would be. Not only that, the
					window is labelled as opening, which is totally unacceptable in allowing a clear direct line of sight, with someone in effect right at the
					end of my garden (albeit directly facing 4 Briary Close) potentially peering right into my property from a short distance. The window is level with
					our bedroom owing to the slope of the ground and no other window has a direct view.
					2. Light Pollution. Our rear garden and patio has no 3rd party light sources affecting it, in addition to its privacy. There is no limit to how brightly
					internally illuminated 17 Huson Close may be, flashing lights or television flickering could be visible potentially. Consequently, particularly in the evenings,
					a very visible glow will confront us where before there was no such light or visible street lighting. This is like someone is installing their outside light in
					another"s garden and is totally unacceptable. This is an intrusion on our private space, particularly our patio, as well as being a visible blight and reducing
