- Reduce crown on side of number 4 and 4a HHG. by up to 2 metres to balance and re-shape crown with 6 HHG. side
- Raise canopy all around by up to 6 metres above ground level
- Reduce side next to London Plane tree in number 2 HHG. back to previous points
