CT (Charles Thuairé) expressed that 2010/3112/P Condition 05, which relates to soft & hard landscaping and means of enclosure, could be argued to include the front land and front boundary railing. On this basis, an application to re-discharge condition 05 could be launched for the front railings approval, but is not advised by CT. CT advised that a full application is submitted. Application is required to show the use and treatment of the newly acquired front land and south boundary enclosure/ boundary treatment.

A 2m high timber fence between 28 Belsize Lane and Belsize Court was discussed between ABA and CT, stepping down to 1m at the front, in timber to match the west party wall. CT had no objections in principle.
