Prune TG3 Pleached hornbeams (carpinus betulus) x4 located at the back of property according to the following specifications:

- prune to maintain the pleached affect

Prune TG4 Photinia group located at the left rear of property rear garden according to the following specifications:

- Reduce to maintain pleached affect but keep height of trees
Prune T6 Hawthorne located at the right side of rear garden according to the following specifications:
- Reduce crown height and spread by approximately 1-1.5 metres to enhance natural form.
- Prune T7 Lilac located at the right side rear of house according to the following specifications:
- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
- Reduce crown height by approximately 0.2-0.5 metres to enhance natural form.
